

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family and covers what the law calls [atlanta personal injury attorney](#) the full value of the life that was lost. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Georgia law sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some of them are <https://go.bubbl.us/f385aa/82fa?/Bookmarks> shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.
