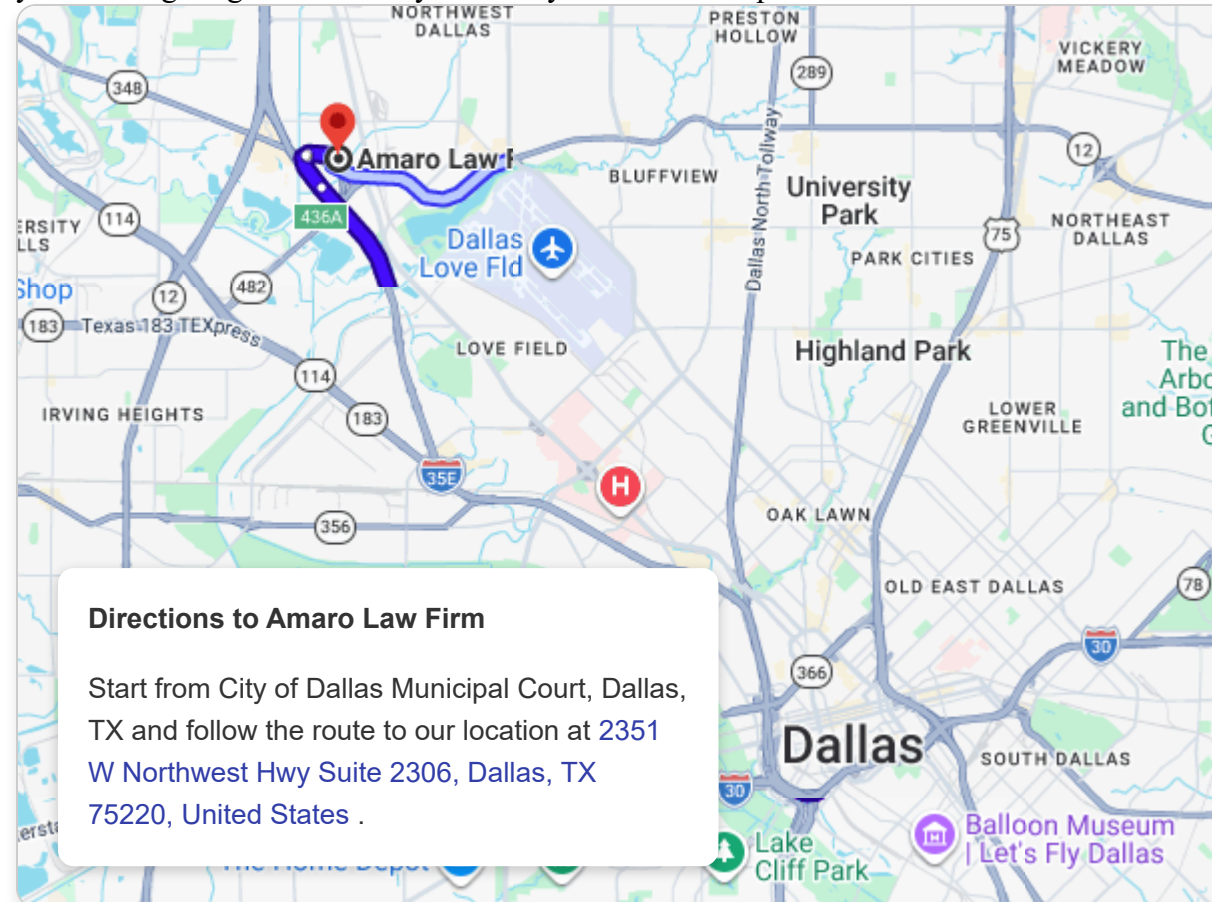

Understanding Your Medical Bill Responsibilities

Every insurance policy has a certain protection restriction, which is the maximum amount the insurance provider will pay for injuries or problems resulting from a mishap. When you've reached this limitation, the insurance firm might refuse to cover further clinical expenses, even if your therapy is ongoing. For instance, if your clinical expenditures surpass the plan's limit, you may have to cover the remaining balance on your own. This is especially real with minimal coverage plans, where the limitations are commonly also reduced to fully cover severe injuries.
