How Does Material Classification Determine Salvage versus Removal Routes?

The first step in triage is identifying what material you are dealing with. Drywall, for example, is porous and absorbs moisture readily. Surface mold on drywall—visible only on the face and contained to the top eighth-inch—can sometimes be cleaned and the board salvaged with encapsulation coating. But if mold has penetrated deep into the paper and gypsum matrix, or if the board was wet for more than 48 hours, removal is the only safe route. Insulation, similarly, cannot be fully decontaminated once saturated; it must be removed and replaced.

Wood framing and joists present a more nuanced triage decision. Surface mold on lumber can be cleaned with appropriate antimicrobial treatment, but structural wood that has absorbed moisture and shows deep mycelial growth must be removed and sistered or spliced with new lumber. Concrete and masonry are non-porous, so mold cannot penetrate; these materials can almost always be salvaged with surface cleaning and moisture control. Metal and tile follow the same principle—they salvage cleanly because mold cannot embed itself into their structure.

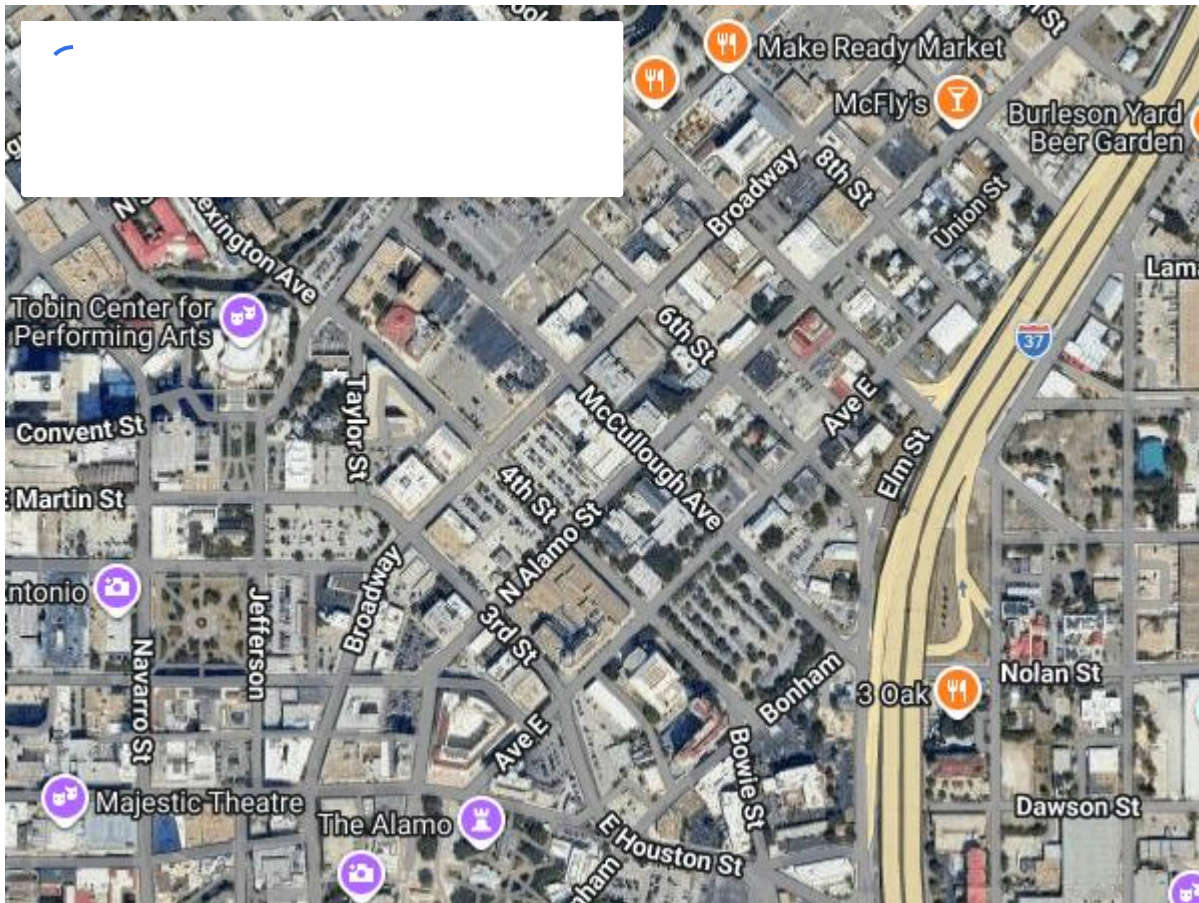
