

If a dog bit you around Atlanta, the legal standard surprises most people.

Some states hold the owner responsible no matter what. Georgia is not [atlanta personal injury attorney](#) one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

Records disappear quickly here. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
