Virginia Code section 20-107.1 directs courts to consider the duration of the marriage, each spouse's income and earning capacity, the standard of living established during the marriage, the age, physical, and mental condition [experienced criminal defense lawyer](#) of each party, and contributions made during the marriage, including those as homemaker and caregiver.
