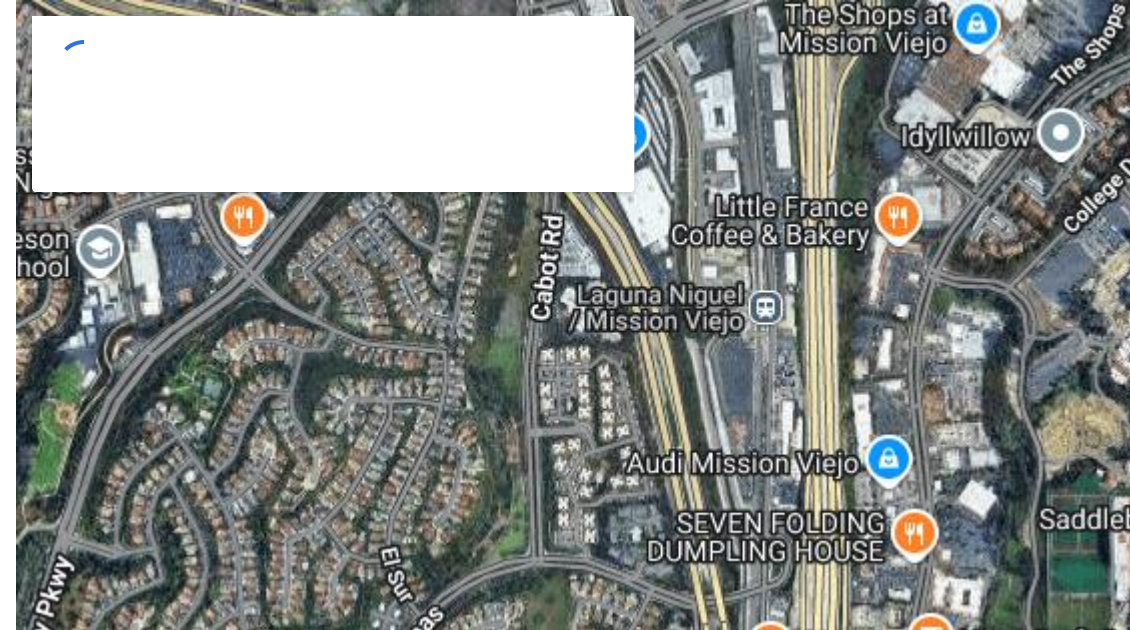
How Trust Administration Differs from Probate

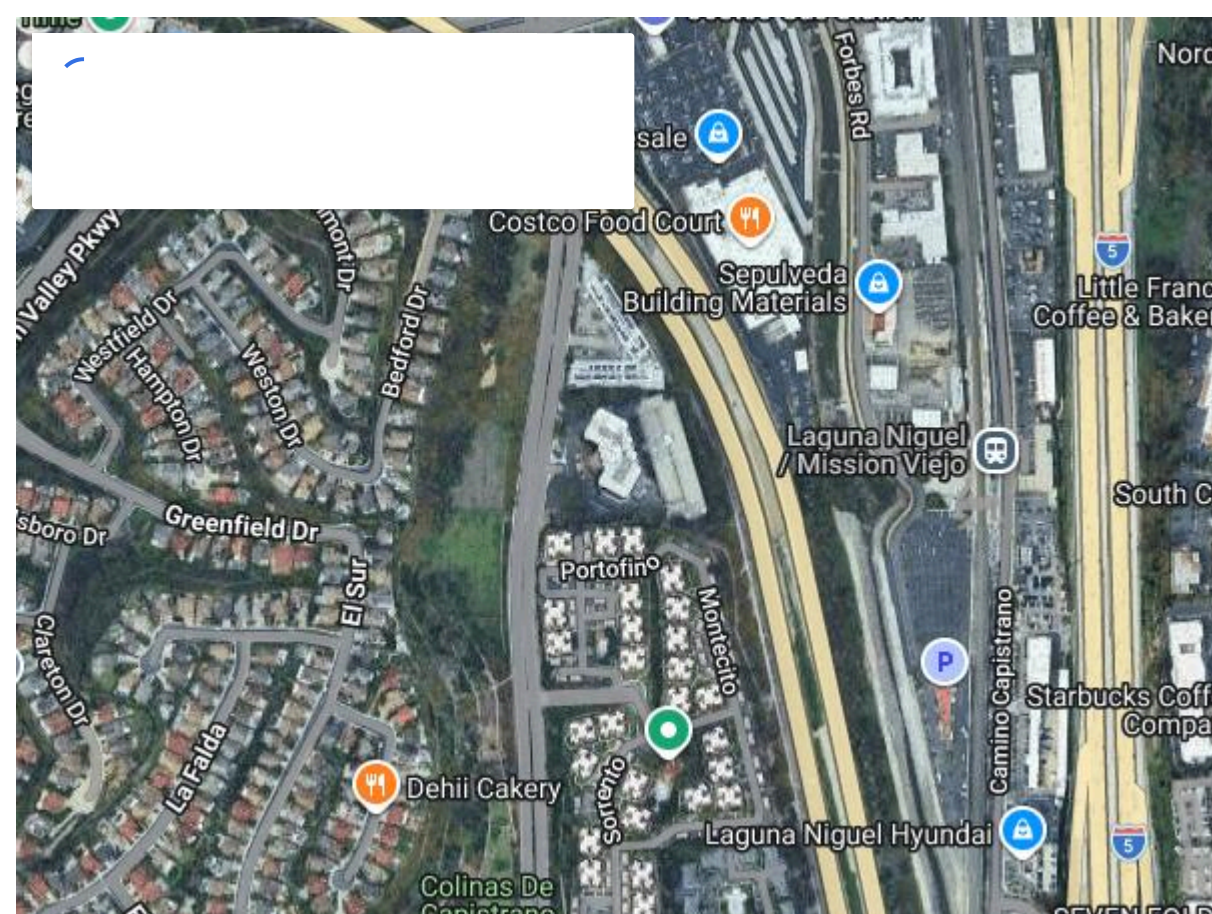
