

If a dog bit you in the Atlanta area, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether a complaint was ever filed.

These records fade fast. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
