

If you were hurt by electrical contact around Atlanta, there is usually more than one responsible party.

There is the property owner, the general contractor, the electrical subcontractor, sometimes a utility, occasionally an equipment maker, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
