

If you or your child were bitten in Atlanta, the rules may not be what you assume.

In some places <https://violetmetric.com/s/FTqcEt9d37QJ7Ljj5vEJ4> an owner is liable automatically. Georgia is not one of them. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
