

Losing someone in a preventable crash is not a legal problem first. It becomes one later, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. Two separate claims generally exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious suffering before death.

Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. [Atlanta 18-wheeler accident lawyer](#) Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, particularly where a commercial vehicle or a business is involved.
