

If you were hurt by electrical contact around Atlanta, several companies may share responsibility.

There is the property owner, the general contractor, the electrical sub, sometimes a utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim [atlanta truck accident lawyer Flanagan Law, P.C.](#) against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. ## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
